### PARKING RULES AND REGULATIONS FOR INCLEMENT WEATHER

All residents should be aware that when snow events are predicted by the weather bureau and/or a phone blast is sent out by management, there is no parking permitted on side streets. Cars must remain off of the side streets until management permits parking.

Residents must comply and park their cars in their private garage, or on Acorn Ponds Drive, in order to provide prompt snow removal.

### REMINDERS

- There is absolutely no parking permitted within 10 ft. of a fire hydrant. Residents in violation will receive a \$200 fine and the police will be notified.
- Parking is not permitted in the cul-de-sac on school days between the hours of 7:00 am - 9:00 am and 2:00 pm - 4:00 pm. Violators will receive a \$200 fine.

### CAR PERMITS

New residents and residents with new cars MUST register their vehicles with the Condo office.

If you have a car that is not yet registered, please make it a priority to bring in your registration to the on-site management office so we can issue you a car permit and update our records.

It is very important that we have all residents' cars registered, whether you own or rent a unit.

We are now following up with parking violators by checking license plate numbers.

If you are a resident without a permit on your vehicle, you are subject to a \$200 fine.

### VERIZON SERVICES

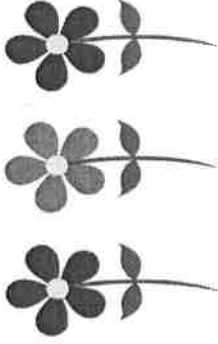
